## MoF invites Public Consultation on UAE Corporate Tax

### Announcement

Further to the UAE corporate tax announcement, the Ministry of Finance (MoF) has invited stakeholders to provide comments on the consultation document from April 28, 2022.

As per the MoF statement, clear and concise comments would be encouraged. The comments from the stakeholders should focus on aspects that may help reduce compliance costs, complexity and improve certainty for both the tax administration and taxpayers. The stakeholders may also provide comments on topics which are relevant but not specifically covered in the consultation document.

This is a significant development and provides an opportunity for all stakeholders to provide inputs directly on issues of importance.
